6. East Portland Transportation Updates:

Powell Blvd. Improvements Start: Tree Removals and Utility Relocations on Outer Powell Begin November 2018. Before roadway construction can begin, things like tree removals and utility relocations will occur along Powell Boulevard from SE 122nd Avenue to SE 136th Avenue. What can be expected from to early 2019?

Contractors will work their way through the corridor removing trees from areas where future sidewalks and bike lanes will be built.

Expect traffic delays. Construction will be intermittent. Flaggers will be in place to direct traffic. If needed, the contractor may hold traffic up to 10 minutes if they foresee a safety risk when removing tree limbs and trunks. Tree removal work will occur during weekdays from 7 a.m. to 10 p.m. and may work weekends.

To minimize impacts to the traveling public, Portland General Electric (PGE) will perform utility relocation activities along SE Powell Boulevard at night from 8 p.m. to 6 a.m. However, work along SE 136th will include daytime hours from 7 a.m. to 5 p.m. Access will be maintained but at a limited capacity. Expect traffic and delays.

Driveway access will be maintained or temporarily accommodated during construction.

No on-street parking will be permitted during construction. When construction is complete, sidewalks and bike lanes will occupy the area currently used for parking on the street.

During certain activities, portions of the sidewalk and bike lanes may be temporarily flagged or redirected to protect people from construction activities and allow the contractors space to load and haul debris. Additional guidance and signage will be provided on site during these activities.

Interstate 205 – East Portland Freeway – Glenn Jackson Bridge to Johnson Creek Boulevard: This project will pave 9 miles of I-205 between Johnson Creek Boulevard and the Glenn Jackson Bridge, including some ramps, build auxiliary lanes in three locations, install ODOT RealTime electronic signs and make pedestrian improvements at Glisan Street. Traffic Impacts: Nighttime double lane closures in both directions from 8 p.m. to 5:30 a.m. Periodic on- and off-ramp closures for striping. For more information: www.i205construction.org

Halsey/Weidler Street Improvement Project: Construction is currently underway on the Halsey/Weidler Street Improvement Project and is scheduled to be completed in summer 2019. This project includes pavement reconstruction on NE Halsey, traffic signal upgrades at 102nd and Halsey/Weidler and pedestrian and bicycle safety improvements along NE Halsey and NE Weidler Street between NE 102nd and 112th Avenue.

<u>East Portland Active Transportation to Transit Project</u>: Scheduled to begin construction in spring 2019. The project will improve pedestrian safety and access along SE Division Street between 102nd and 157th by

infilling missing sidewalk, building ADA-compliant curb ramps and driveway connections and installing three new signalized crossings. This project will also install the 130's Neighborhood Greenway, a new north-south bicycle and pedestrian route between the Springwater Corridor Trail and the I-84 Multi-Use Path. Keep an eye out for more info about this project in the coming months!

NE 102nd Pedestrian Crossing Planning Effort: In partnership with Prosper Portland, the Portland Bureau of Transportation is working to find better ways to link the Gateway Transit Center and the Halsey-Weidler Business District. City staff will work with the Gateway community to identify one or two locations to build safer pedestrian crossings on NE 102nd Avenue between NE Halsey St and NE Glisan St. The project team has identified preliminary locations and evaluated each location's feasibility. They are reaching out to the community to understand which of the crossing locations would most help people safely get around. This planning work is funded by a \$100,000 agreement with Prosper Portland that will also look for funding sources for the crossings (such as Local Improvement Districts, Transportation System Development Charges and redevelopment), reexamine the Gateway Master Street Plan, suggest improved connections through the Gateway Shopping Center, and provide technical assistance to community groups who have been awarded grants for Gateway Identity Projects to improve the sense of place in Gateway. East Glisan Street Update: Portland Bureau of Transportation is in the process of completing additional traffic modeling and considering street cross-sections for NE Glisan between 102nd and 162nd. We have also reviewed, and are taking into account, comments from residents from our online survey and open houses that occurred summer 2018. PBOT expects to make decisions about the cross section of NE Glisan spring 2019. We are appreciative of the many residents who took time to provide input on this project and we are using this opportunity to do further analysis of the corridor.
